# 2021, A Great Year

As these very unique times continue, we have remained focused on our Core Values, Mission, and Vision by positioning the Bank and the Foundation to help our communities achieve financial success, health and well-being. While not only celebrating our 15th Anniversary in 2021, we have also hit record profits, assets, loans, deposits and stock price – the Big Five in the community banking industry.

As you will see, our net profit increased 26% in 2021 to \$5,159,320. Assets were up almost 17% to \$474 million and deposits were up 19% to \$433 million. Our loans were up 14% or \$29 million, net of the SBA Paycheck Protection Program (PPP) loans. We made a total of 772 loans in both rounds totaling over \$130 million – a huge amount for a Bank our size.

We remain a well-capitalized bank far exceeding minimum regulatory requirements. Our loan quality continues to be excellent as we have no loans that could be considered “non-performing.” We have not incurred a loan loss in several years and have built an impressive reserve to protect us from any future losses.

Through our Community Foundation we actively support local causes at a high level of commitment. We continue to assist Camp Fire victims, support efforts to lessen the impacts of the pandemic and contribute to many other great causes in our communities.

In August we purchased a well located building in Oroville, and look forward to it operating as a full service office in mid- 2022. Based on the number and quality of our existing Oroville customers, we recognize it is an underserved market where we can focus efforts on providing financial opportunities for more businesses customers.

We are happy to announce four new members on our Board of Directors – Sierra Grossman, Vice President at Sierra Nevada Brewing Company; Mike Phulps, the CEO of Metal Works; Brent Largent, CEO of Stratti; and Tom Hughes, recently retired from Interwest Insurance Services.


We realize that 2022 could bring some challenges to our economy with inflation, rising interest rates and this lingering pandemic.

## Major Contributions in 2021



Our Redding office employees worked throughout the year and they were able to present a check for \$3,005 to the Wild Horse Sanctuary.





# Proud Presenting Sponsor
